



RESOLUTION NO. R-2021-03-02

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE ROBERTS CREEK WATER DISTRICT CALLING AN ELECTION ON THE QUESTION OF DISSOLUTION OF THE DISTRICT UPON FORMATION OF JOINT AUTHORITY

WHEREAS, on March 11, 2021, the Roberts Creek Water District’s Board of Directors (“Board”) adopted Resolution No. 2021-03-01, making findings of fact and adopting a plan of dissolution and liquidation; and

WHEREAS, voter approval of dissolution shall be conditioned upon voter approval of formation of the Green Area Water and Sanitary Authority at the May 18, 2021 election; and

WHEREAS, ORS 198.935 requires the Board, within 10 days after filing the plan of dissolution and liquidation with the county clerk, to call an election on the question of whether the District shall be dissolved, its indebtedness liquidated, and its assets disposed of in accordance with the plan proposed;

NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

1. The Board hereby calls an election in Douglas County, Oregon, for the purpose of submitting to the electors of the District the question of whether the District shall be dissolved contingent upon voter approval of the formation of the Green Area Water and Sanitary Authority.
2. The proposed ballot title for such election is attached hereto as Exhibit A and incorporated herein by this reference.

DISSOLUTION OF WATER DISTRICT UPON FORMATION OF JOINT AUTHORITY

Shall the Roberts Creek Water District be dissolved upon formation of a Joint Water and Sanitary Authority?

This measure would approve the dissolution of the Roberts Creek Water District contingent upon voter approval of the formation of the Green Area Water and Sanitary Authority, also on this ballot.

The boundaries of the proposed Authority are identical to those of the water district, which encompasses the boundaries of the Green Sanitary District. Neither of the existing districts assesses a permanent tax rate and none is proposed for the Authority.

If formed, the Authority would continue to provide domestic water supply services and sanitary sewer services within the current boundaries of the Green Sanitary District and the Roberts Creek Water District. If the formation of the Authority is not approved by voters, the districts will not be dissolved and will continue to operate as they did before the election.
